

**Details of MEMORANDUM OF UNDERSTANDING (MOU)
Between
St. Wilfred's College for Girls, Jaipur
And
Gyan Ashram School, Jaipur**

This Memorandum of Understanding (MOU) Between St. Wilfred's College for Girls, Jaipur, India (hereafter referred to as "SWCG"), represented by its Principal, Dr. Manisha Tiwari and Gyan Ashram School, Jaipur, India (hereafter referred to as "GAS"), represented by its Principal, Dr. Beni. This Memorandum of Understanding (hereafter referred to as "MOU") is made and entered into on this day of 1st May, 2023 between St. Wilfred's College for Girls, Jaipur (hereafter referred to as "SWCG") and Gyan Ashram School, Jaipur, India (hereafter referred to as "GAS").

BACKGROUND:

SWCG and GAS recognize the mutual benefits that can be derived from the sharing of physical facilities, including ground, swimming pool, sports facilities, and gym at GAS. The Parties have therefore agreed to enter into this MOU to govern the terms of use of these facilities.

TERMS:

1. **Use of Facilities:** GAS agrees to provide SWCG with access to its physical facilities, including ground, auditorium, sports facilities, and gym, subject to availability and GAS Scheduling.
2. **Scheduling:** SWCG and GAS shall work together to develop a mutually agreeable schedule for the use of the facilities. In the event of a scheduling conflict, GAS shall have the final say in determining the Schedule.
3. **Liability:** SWCG and GAS will decide any kind of liability occurred out of usage of facilities with mutual consent.
4. **Termination:** This MOU may be terminated by either Party upon thirty (60) days' written notice to the other Party.
5. **Entire Agreement:** This MOU constitutes the entire agreement between the Parties and supersedes all prior negotiations, understandings, and agreements between the Parties, whether oral or written.
6. **Governing Law:** This MOU shall be governed by and construed in accordance with the laws of the State of Rajasthan, India.





EFFECTIVE DATE AND SIGNATURE

This MOU shall be effective upon the signature of St. Wilfred's College for Girls and Gyan Ashram School authorized officials. It shall be in force from 01/3/2017 to 01/3/2025.
